Volunteer Waiver of Liability

Thank you for working today. We greatly appreciate your assistance and commitment to forwarding the Mission and Vision of Seven Generations. Our insurance policy requires that we have an accurate record of all volunteers. This is an annual form where you agree to release Seven Generations of all liability while performing volunteer work for the school. **This form is in effect for one year from the signing date.**

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____ 20____, by _____ (the "Volunteer") in favor of Seven Generations Charter School, its directors, officers, employees, and agents (collectively, "Seven Generations").

The Volunteer desires to work as a volunteer for Seven Generations and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include physical labor, operating personal motor vehicles and other support or volunteer work on behalf of Seven Generations.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver: Volunteer does hereby release and forever discharge and hold harmless Seven Generations and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Seven Generations.

Volunteer understands that this Release discharges Seven Generations from any liability or claim that the Volunteer may have against Seven Generations with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's Activities with Seven Generations, whether caused by the negligence of Seven Generations or its officers, directors, employees, or agents or otherwise. Volunteer also understands that Seven Generations does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment: Volunteer does hereby release and forever discharge Seven Generations from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Seven Generations.

Assumption of the Risk: The Volunteer understands that the Activities includes work that may be hazardous to the Volunteer, including, but not limited to, physical activity, labor, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Seven Generations from all liability for injury, illness, death, or property damage resulting from the Activities.

Insurance: The Volunteer understands that, except as otherwise agreed to by Seven Generations in writing, Seven Generations does not carry or maintain health, medical, or disability insurance for any Volunteer.

Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release: Volunteer does hereby grant and convey unto Seven Generations all rights, title, and interest in any and all photographic images and video or audio recordings made by Seven Generations during the Volunteer's Activities with Seven Generations, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Pennsylvania and that this Release shall be governed by and interpreted in accordance with the laws of the State of Pennsylvania. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
